Shipping Guidance Notice 042(a) **Requirement of Publications (Revised)** *Supersedes SGN 042*

To: Ship Owners, Operators, Master's, Classification Societies and Recognised Organisations

Requirement of Publications

Gibraltar-registered ships are required to carry on board:
