DECLARATION OF ELIGIBILITY BY A CHARTERER

Please read these notes and refer to them as necessary when completing this form:

1. Write in black ink using **BLOCK CAPITALS**, and tick boxes where appropriate.
 2. A ship is entitled to be bareboat registered on the Registry of Ships if the charterer is qualified, i.e.:
 - a. Bodies corporate incorporated in an European Economic Area State or EU Member State and having appointed a representative person;
 - b. Bodies corporate incorporated under the Law of Gibraltar and having their principal place of business in Gibraltar or having appointed a representative person;
 - c. A Foreign Maritime Entity.
- ◆ **Representative Person**
1. If the charterer is not a body corporate incorporated or registered in Gibraltar and having its principal place of business in Gibraltar, a representative person must be appointed.
 2. A representative person is either an individual resident (†) in and having a place of business in Gibraltar or is a body corporate incorporated or registered under the Laws of Gibraltar and having its principal place of business in Gibraltar and having as a part of his business acting as a representative person.
 3. The representative person must consent to his appointment in writing. Any changes of name, address or representative person must be communicated to the Registrar within seven days of such.

SECTION 7: DECLARATION

I hereby declare that -

- a) The information given by me in this form is true to the best of my knowledge and belief.
- b) The Body Corporate / Legal Entity / Foreign Maritime Entity* is able to bareboat register the ship in its name as Bareboat Charterer.
- c) The Bareboat Charterer is a person eligible in accordance with Section 7 of the Act.
- d) The ship is entitled to be Bareboat Registered and it is not a ship to which section 14(2) of the Act applies and it is not a prohibited ship by virtue of Regulation 16 or a Notice made thereunder.
- e) The Body Corporate / Legal Entity / Foreign Maritime Entity* is entitled to be registered as the Bareboat Charterer of the ship as specified in Section 1 of this form.
- f) The general description of the ship contained in this form as specified in Section 1 and in greater detail in the Application to Bareboat Register a Ship Form attached to this declaration is correct.
- g) The ship is registered outside Gibraltar as specified in the Application to Bareboat Register a Ship Form attached to this declaration.
- h) The Representative Person specified in Section 5 has consented to act in that capacity in respect of the Bareboat Charterer.
- i) The Responsible Individual specified in Section 6 has consented to act in that capacity in respect of the ship and is competent to do so.
- j) The Registered Agent specified in the Application to Bareboat Register a Ship Form attached to this declaration has consented to act in that capacity in respect of the ship.
- k) The Bareboat Charterer has entered into a Charter Party in the terms of the Certified True Copy of the Charter Party attached to this declaration which is a true and complete copy thereof.
- l) The consent of the owner of the ship to the Bareboat registration in Gibraltar by virtue of the Charter Party of the ship has been obtained and it is attached to this declaration.
- m) The consent of each mortgagee (if any) of the ship to the Bareboat registration in Gibraltar by virtue of the Charter Party of the ship has been obtained and it is attached to this declaration.
