REGISTRATION OF A SHIP UNDER CONSTRUCTION

Application for registration of a ship under construction.

51.(1) An application for registration of a ship under construction on the Register of Ships under Construction shall be made to the Maritime Administrator and may be made in respect of any ship which, on completion of construction, may be registered on the Register and may be made at any stage of construction.

- (2) An application under sub-regulation (1) shall be made –
- (a) in the specified form;
 - (b) accompanied by information supplied by the builder which shall include –
 - (i) the construction hull number of the ship;
 - (ii) the intended length, breadth and depth of the ship;
 - (iii) the intended capacity of the ship;
 - (iv) the location of the construction;
 - (v) the name and registered address of the shipbuilder;
 - (vi) the reason for registration;
 - (vii) a statement issued by the intended Classification Society of the Class Notation of the ship;
 - (viii) any ship building contract, bill of sale, mortgage or related instrument to be recorded in respect of that ship; and
 - (ix) the prescribed fee.
